#### **DAY 6: FRANKENMUTH - NIAGARA FALLS**

Later enjoy the unique "Journey Behind the Falls" experience where you descend 125 feet and explore 130-year-old tunnels carved through the bedrock. Later check into your hotel for two nights in Niagara Falls.
